Enclosed, please find the 2002 Uniform Business Report for Mo Steel Fabricator & Erector, Inc. along with a check for the annual report fees.

Based upon a recent discussion with one of your representatives, we were informed that it might be possible to abate the \$400 penalty upon written request with reasonable cause for late filing.

The company would like to request an abatement of the \$400 penalty. The reasonable cause for this request is the reliance of the company's president upon the registered agent to handle all corporate state filing matters for the corporation and the subsequent failure of that registered to perform the hired tasks properly.

The registered agent, who was hired to file the annual report, did not receive the copy of the annual report and did not follow up on the corporation's behalf to obtain and file such form as required. Due to his negligence, the annual report was not filed, and accordingly, the corporation has been penalized due to late filing.

The company's president was only recently made aware that his corporation's annual report was not filed timely is therefore filing this report at this time. As a result, the corporation has named the president as the registered agent and dismissed the prior registered agent from service.

Thus, the company is requesting an abatement of the \$400 penalty since the corporation relied upon a paid professional to handle the filing of the annual report and since that paid professional negligently failed to perform the hired tasks.
