**ARTICLE I - NAME**

The name of this corporation is: Bobbi's Colour Studio, Inc.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III - PRINCIPAL PLACE OF BUSINESS**





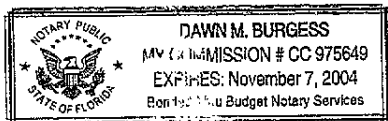
