To whom it may concern,

I am writing in reference to Expressions of New Life Productions Inc., filed Nov. 21, 2001. My name is Janet Rowland and my partner is Cheyrl Carleton. Our assigned document # PO1000111389.

November 26, 2002, I received certified letter from our lawyer, Jeanie Helton that our Corporation had been dissolved due to not filing a Uniform Business Report. It was my understanding that we were paying this lawyer to handle all of these documents. Our lawyer did not even send us papers to file for a ss-4 document for our Federal Employer Identification # until January 25, 2002. It is my understanding that you must have this # to apply for the Uniform Business Report. According to the paperwork I just received from my lawyer, this form was not processed until April 5, 2002.

After confronting my partner about this incident, I am told that she did receive application to register a Uniform Business Report. It was mailed to her address because she is the President of the Corp. I am the Vice-President and was completely unaware of all of this due to lack of communication from our lawyer. By the time my partner received identification # and filed report, it was after the May deadline and she was denied paying \$150. Therefore, because of money and time, she did not file the report.

I am requesting that you receive \$150.00 for us to apply for the Uniform Business Report being that I did not receive application at my address. I understand that you mail the application to the address of the Corp. but under the circumstances, I am asking you to reconsider. We have paid \$1000 to be incorporated by this lawyer and one year later are learning our Corporation has been dissolved because of this.
