The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is S.F. Windows & Doors, Inc. Principal place of business is 2175 N. Powerline Road, Suite 2, Pompano Beach, Florida 33069.

**ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.


### ARTICLE VIII: INCORPORATOR


