**ARTICLE I - NAME**

The name of this Corporation is Savant Aircraft Corporation; the mailing address is 1931 NE 7th Court, Fort Lauderdale, Florida 33304.

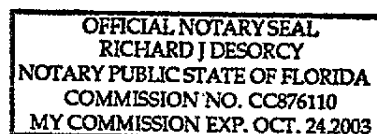

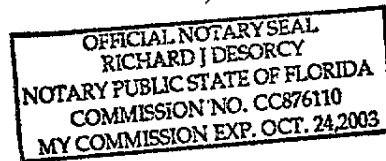
