

ARTICLES OF INCORPORATION of K. & F. CORPORATION



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: K. & F. CORPORATION

ARTICLE II

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 2777 Joseph Circle, Oviedo, FL 32765. The mailing address of the corporation is the same.

ARTICLE III

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE IV

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:
