The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The date of commencement of corporate existence shall be on filing of the Articles of Incorporation and the Corporation shall have perpetual existence.

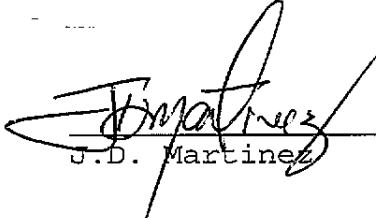

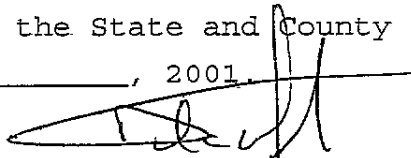
