Articles of Incorporation
of

Article I - Name

The name of this corporation is and shall be Alternative Communication Pathways, Inc.

Article II - Purpose

The corporation is organized for the purpose of providing services in the areas of Augmentative and Alternative Communication, Assistive Technology and Speech and Language and any other services legal in the state of Florida. This includes therapy, consulting, instructing and the purchase and sale of related equipment and supplies. Services will be provided at the client site or in an office designated for such work, and of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida. .

Article III - Capital Stock

The aggregate number of Shares of Capital Stock which the Corporation shall have the authority to issue is 6,000, all of which will be Common Shares without Par Value and be Original Issue Stock according to Internal Revenue Code Section 1244.

The Corporation reserves the right to amend or repeal an provision contained in these Articles of Incorporation or any amendment hereto.

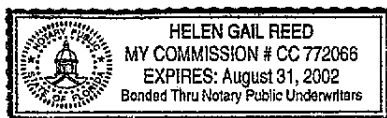
