ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. - CORPORATE NAME

The name of the Corporation is MARTIN ZFAZ, M.D. P.A., a Florida Professional Association.


