ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE 1- NAME

The name of this corporation is PLANTATION LAWN & MAINTENANCE, INC.

ARTICLE 2- PRINCIPAL OFFICE

ARTICLE 3- PURPOSE




