**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
ENVIRONMENTAL AIR CONDITIONING SERVICES, INC.**

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of ENVIRONMENTAL AIR CONDITIONING SERVICES, INC., a Florida corporation (the "Corporation"), and in connection therewith, the undersigned officer, acting upon the authority of the Board of Directors of the Corporation, and upon authority of the holders of all of the shares entitled to vote on said amendment hereby set forth as follows:

1. The name of this Corporation is ENVIRONMENTAL AIR CONDITIONING SERVICES, INC.
2. The Articles of Incorporation for this Corporation were filed on November 26, 2001 and assigned Florida Document Number P01000111914.
3. The Articles of Incorporation of ENVIRONMENTAL AIR CONDITIONING SERVICES, INC. have been amended by deleting Article I in its entirety and by substituting the following in lieu thereof:

"ARTICLE I – NAME

The name of this Corporation is Stalls Investment Holdings, Inc."


