# ARTICLES OF INCORPORATION

# ARTICLE I - NAME

The name of this corporation is Money Master Financial Corp.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be 90 Wellington Hill Street

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
