The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I. NAME

The name of the corporation is Total Property Maintenance of Manatee, Inc.

The term of existence of the corporation is perpetual.


