## ARTICLE III

## HMK PROMOTIONS LTD.

2. The purpose or purposes for which the corporation is formed are as follows; to wit:

To own operate, manage and do everything normally associated with conducting the business of advertising. To write, prepare, publish and display, in any and every manner, advertisements and publicity devices of all kinds for itself and others. To arrange and/or give demonstrations and exhibitions for advertising purposes; to supervise the preparation and production of motion picture and videotape advertisements and publicity devices. To engage in any lawful act or activity for which corporations may be formed under the Business Corporation Law. The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

To own, operate, manage, acquire and deal in property, real and personal, which may be necessary to the conduct of the business.
