ARTICLES OF INCORPORATION

We, the undersigned, hereby come together for the purpose of becoming incorporated under the laws of the State of Florida applicable to incorporation and the following proposed charter:

ARTICLE 1 NAME

The name of the Corporation shall be: COSQUER ISMAEL AND ASSOCIATES, INC., located in Broward County, Florida.

ARTICLE 2 ADDRESS

ARTICLE 3 PURPOSE


