ARTICLE THREE      SHARES

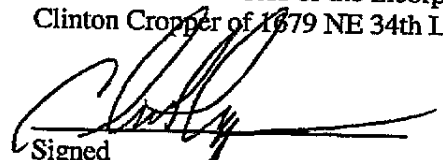

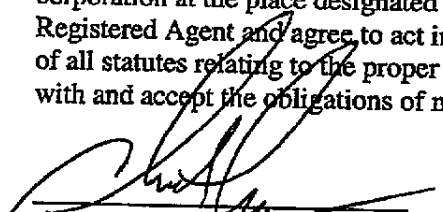
