ARTICLE 8 - SUB-CHAPTER S CORPORATION

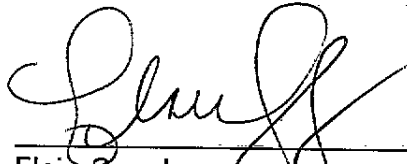

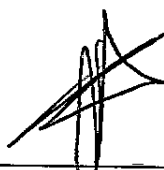
