**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **RAYMOND M. CASS, JR., P.A.**

ARTICLE II

The corporation may engage in the practice of law in the State of Florida. Further, the corporation may perform such other necessary and reasonable acts in any manner associated with the practice of law. The corporation may also engage in any other activity permitted under Chapter 621, Florida Statutes.

ARTICLE III

The capital stock of this corporation shall consist of 100 shares of common stock. The common stock shall not carry a par value and each share shall be entitled to one vote. Consideration to be paid for each shall be payable in lawful money of the United States or any property, labor or services at just valuation to be fixed by the stockholders. Stock shall be subject to pre-emptive rights.

ARTICLE IV

The amount of capital with which this corporation will begin business is \$100.00.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VI

The initial street address of the principal office of this corporation in the State of Florida is 188 Harpers Ferry Drive, Daytona Beach, Florida 32119. The common stockholders may from time to time move the principal office to any other address in Florida and the corporation shall have the right and power to transact business and have offices and agencies in such other places as the common stockholders may from time to time authorize.

ARTICLE VII

The registered office of this corporation shall be initially 188 Harpers Ferry Drive, Daytona Beach, Florida 32119, and its initial registered agent shall be RAYMOND M. CASS, JR. Such registered office or agency may be redesignated by a majority of the stockholders entitled to vote and in such case, the redesignation shall be effective upon filing such redesignation in the form and manner required by law.

ARTICLE VIII

The name and post office address of the subscriber to Articles of Incorporation is as follows:

ARTICLE IX

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a stockholders meeting by a majority of the stockholders entitled to vote thereon, unless all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation is made.

ARTICLE X

The effective date of the corporation shall be five business days prior to the date of filing of these Articles.

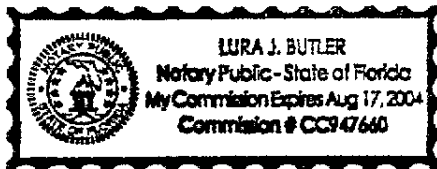

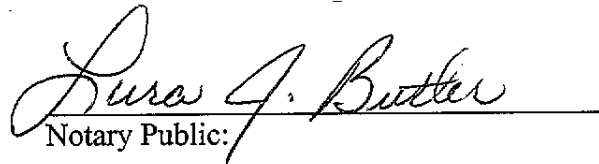
