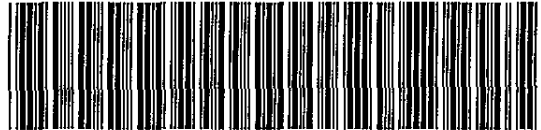

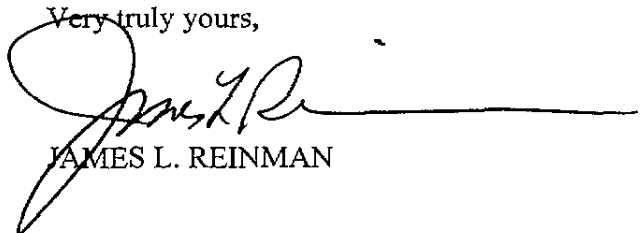

PURSUANT to Section 607.1403 of the Florida Business Corporation Act, the Corporation submits these Articles of Dissolution.
