## ARTICLES OF INCORPORATION

#### **OF**

NATIONAL PROCESS SERVERS, INC.

The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

### ARTICLE I - NAME

The name of this corporation is: NATIONAL PROCESS SERVERS, INC.

## ARTICLE II - PURPOSE

- A) The general nature of the business to be transacted by this corporation shall be Primarily to engage in the business of services of process and related legal services and in general to perform any duties that may be related thereto.


