The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

Article 1. Name

The name of the corporation is Bill Atchley Floor Covering, Inc., a Florida Corporation.

Article 2. Duration

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department.

Article 3. <u>Purpose</u>

Article 4. Capital Stock
