

ARTICLES OF INCORPORATION
OF
THOUGHTBULB, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I – CORPORATE NAME

The name of the corporation: **THOUGHTBULB, INC.**

ARTICLE II – DURATION

The corporation shall have the power to transact or engage in any business permitted under the laws of the United States and the State of Florida.

ARTICLE III – PURPOSE

The corporation is organized for the purpose of engaging activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV – CAPITAL STOCK

Class "A" Preferred Stock – Ten Million (10,000,000) shares of \$.001 par value Class "A" Preferred Stock upon such terms and conditions as the Board of Directors may determine at the time of issuance, without further action of the shareholders being required. Such preferred shares may or may not be: issued in series, convertible into shares of Class "A" Common Stock, redeemable by the Company, and entitled to cumulative dividends. Other terms and conditions may be imposed at the time of issuance.

Class "A" Common Stock – Fifty Million (50,000,000) shares of Class "A" Common Stock having the par value of \$.001 per share. The holders of Common Stock are entitled to one vote for each share held on all matters submitted to a vote of shareholders. Holders of Common Stock are entitled to receive ratably such dividends, if any, as may be declared by the Board of Directors out of funds legally available therefore, subject to any preferential dividend rights of outstanding Class "A" Preferred Stock. The holders of Class "A" Common Stock have no preemptive, subscription, redemption, or conversation rights.


