To Whom it May Concern:

I am the owner and Director of Creative Ideas Inc. I have just received a "Notice of Administrative Dissolution or Revocation" for failure to file its 2002 corporation annual report.

I am writing this letter to inform you that this is the first correspondence letter that has been delivered to me. The address of my corporation is also my home address and I have had difficulty with the Post Office delivering my mail for the last year and a half. Magazines I have paid for have not been delivered, Credit Card statements that I am supposed to receive monthly have gone missing at times.

I have raised this concern with the USPS and what they tell me is that my company name needs to be in the mail box so that the mail person can confirm that the mail for the corporation is to be expected at that address.

This has been the case now for the last year. I have not received bank statements for my corp. for months at a time, even though I was assured by the bank that it is sent in a timely manner every month. The apartment complex that I live in has installed new boxes as of last month and mail delivery has been normal for the time being.

This brings me to the letter regarding dissolution of the corporation. I called the number on the notice and explained my situation. I was told to write a letter stating exactly what happened and to mail it off with the standard \$150.00 filing fee.

I am humbly requesting that you accept my payment in full and reinstate my corporation name with the state. I have also included 8.75 in order to receive a certificate of status of the corporation.
