ARTICLE I. NAME

The name of this corporation is

BOUF & STANK ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2002 and shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.



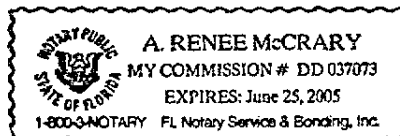
