The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is AWEIGH WE GO, INC. (the "Corporation"). The initial principal office of the Corporation is located at 5550 No. Ocean Drive, Unit 5-A, Singer Island, Florida 33404.

ARTICLE II. DURATION

The term of existence of the Corporation is perpetual.

The Board of Directors of the Corporation shall consist of not less than one (1) nor more than five (5) members. The names and addresses of the first Board of Directors are:


