ARTICLES OF INCORPORATION FOR TAMPA BAY CATERING, INC.

ARTICLE I - NAME

The name of this corporation shall be TAMPA BAY CATERING, INC.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE
