ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, desiring to organize a Corporation under Chapter 607, Florida Statutes, set forth the following:

ARTICLE I

The name of this Corporation shall be: <u>DEWAYNE CURTIS PLASTERING, INC.</u>

ARTICLE II

The duration of the Corporation shall be perpetual.
