# ARTICLES OF INCORPORATION OF VITOLE, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I CORPORATE NAME

The name of the corporation shall be Vitole, Inc. and the corporation's principal address shall be 2349 S W. 34th Way, Fort Lauderdale, FL 33312.

# ARTICLE III NATURE OF BUSINESS AND POWERS

The purposes for which the corporation is organized are to engage in the business of marketing health products, and the general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the United States of America and the State of Florida.

# ARTICLE VIII AMENDMENT

## ARTICLE IX PREEMPTIVE RIGHTS

The holders of the common stock of this corporation shall have the preemptive right to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of stock of this corporation as may be issued for money (money or any property or services) from time to time, in addition to the stock authorized by the corporation. The preemptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.

### ARTICLE X EFFECTIVE DATE

Pursuant to Florida Statute Section 607.0203(1) (2000), the effective date of the commencement of corporate existence is when these Articles of Incorporation are filed with the Florida Department of State.


