ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, hereby act as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Samantha D. Malloy, P.A.

ARTICLE II

The existence of the corporation shall begin upon filing these articles with the Florida Department of State. The purpose of the corporation is to engage in the practice of law and in any other related activities in which professional associations and corporations may engage.

ARTICLE III

The street address of the principal office of the corporation is 315 SE 7<sup>th</sup> Street, Suite 200, Fort Lauderdale, FL.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares. 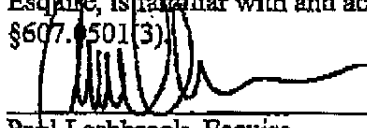
