ARTICLES OF INCORPORATION OF JAVA GOLD COFFEE SERVICE, INC.



<u>ARTICLE I – NAME</u>

The name of this corporation shall be JAVA GOLD COFFEE SERVICE, INC.

ARTICLE II - Street Address and Mailing Address

The address of the principal office and the mailing address of this corporation shall be:

6494 Mockingbird Lane S., Clearwater, Florida 33760

ARTICLE III - Duration

This corporation shall have perpetual existence.

ARTICLE IV -PURPOSE

This corporation is organized to include the transaction of any or all lawful business for which it may be incorporated under Chapter 607, Florida Statutes as presently enacted and as it may be amended from time to time.

<u>ARTICLE V – CAPITAL STOCK</u>

- 4. <u>Dividends</u>. Any and all dividends are to be shared among the holders of shares of outstanding Class A Common Stock on a share for share basis.

ARTICLE VI -- Registered Office and Registered Agent

The initial registered office of this corporation shall be located at 6494 Mockingbird Lane S., Clearwater, Florida and the initial registered agent of this corporation at such office shall be Russell A.
