THE UNDERSIGNED, acting as sole incorporator of a professional corporation for profit to be formed under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

FIRST:

SIXTH: The number of directors constituting the initial Board of Directors of the Corporation is two (2). The number of Directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1). SEVENTH: The general purposes for which this Corporation is organized shall be:

- To render professional medical services to the general public, and to do all things
 in connection therewith that are customarily done by doctors of internal medicine under the laws
 of the State of Florida.
- In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation Act.

EIGHTH: No one other than an individual who is duly licensed or legally authorized to render medical services in the State of Florida may own stock of this Corporation. No Shareholder of this Corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock. Any Shareholder who becomes legally disqualified to render medical services shall sever all employment with and financial interest in the Corporation. No Shareholder of the Corporation may sell or transfer his stock in this Corporation, except to another individual who is eligible to be a Shareholder of the Corporation.

NOW, THEREFORE, the undersigned, being the sole incorporator hereinbefore named, for the purpose of forming a corporation under the Florida Business Corporation Act has executed these Articles of Incorporation this 25 day of November, 2001.
