#### **ARTICLE IV**

##### **Existence of the Corporation**

This Corporation shall have perpetual existence. Commencement shall be effective this 28<sup>TH</sup> day of November, 2001.

#### **ARTICLE V**

##### **Directors**

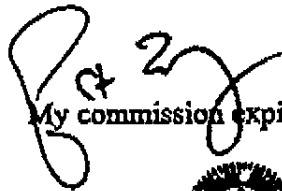
