

Dear Ms. Payne.

Thank you for your call today regarding the 2 documents attached. I apologize for not including the necessary fees with the originals sent.

My husband & I started, (incorporated) Discipline Marketing, Inc. back in 1988 as a Sub-Chapter S Florida Corporation. We had 2 divisions: We sold Apparel under the name DISCIPLINES and Optics (Telescopes & Binoculars), under the name Galileo Visions. Both of the 2 divisions went by their names along with "Division of Discipline Marketing, Inc." after it.

After years of this working just fine, our Lawyer convinced us to separate the one Company, Discipline Marketing, Inc. into two separate Companies.

We changed the name our original company, Discipline Marketing, Inc., (EIN # 65-0060814) to Galileo Visions, keeping the same EIN #. This Company was to be used to sell the Optics.

We then, started a new Company for the Apparel, calling it, "Discipline Marketing. Inc." which received a new Federal EIN #: 60-0002963.

In hindsight, this venture was a mistake and I would like to put the 2 Companies back together under the one original name. Discipline Marketing, Inc. and keep the original EIN#65-0060814.

Therefore, I sent the Articles of Dissolution to dissolve the existing Discipline Marketing, along with Articles of Amendment to change the name of Galileo Visons Inc. BACK to Discipline Marketing. Inc.

I have enclosed 2 separate checks for \$35 each to process each document. Please let me know if I have left anything out.
