The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1 NAME: The name of the corporation shall be Drums Autobody, Inc.

ARTICLE 2 DURATION: The corporation shall have perpetual existence.


