**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
KURT FORREST BREWER, P.A.**

Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of KURT FORREST BREWER, P.A. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on November 29, 2001.

1. The members of the Board of Directors of the Corporation have recommended the following proposed change to the Articles of Incorporation to the shareholders of the Corporation, and the shareholders of the Corporation have unanimously voted to change the Corporation's Articles of Incorporation; therefore:

- a. Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

ARTICLE I

Name and Duration

The name of the Corporation is BREWER BOTWIN, P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

- b. Article II of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

ARTICLE II

Principle Office

The principle office of the Corporation is 2300 Curry Ford Road, Orlando, FL 32806.

- c. Article III of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 2300 Curry Ford Road, Orlando, Florida 32806. The name of the registered agent at such address is Kurt Forrest Brewer, Esq.

2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.

3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all the members of the Board of Directors and all the shareholders of the Corporation on the 1st day of January, 2005, and the number of votes cast for the name change amendment was sufficient for approval.
