

ARTICLE I. NAME

The name of this corporation is
RHINO TECHNOLOGIES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 10,000,000 shares



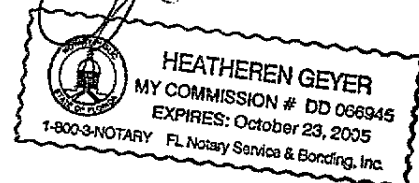
