ARTICLES OF INCORPORATION
for
WILLIAM TODD PAINTER P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is William Todd Painter P.A. Principal place of business is 13503 NW 10th Street, Sunrise, Florida 33323.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
