Gentlemen:


The end of June we received our first notification about our annual report being past due. I promptly mailed in the form and our check for \$150.00, together with a letter of explanation that we had not received our previous notice. A copy of that form and cancelled check are attached.

The end of September we received a letter that our corporation had been dissolved for non-payment and for not filing our report. I called your office and they informed me they had sent another letter to us, which we did not receive either. We have since changed all of our addresses to our home address and moved our office to that location as well. We were experiencing problems in receiving some of our mail at our other location on Seminole Boulevard, so I do not know why we did not receive those notices. The notification the end of September was sent to our home address, which we are now using for all correspondence, etc.
