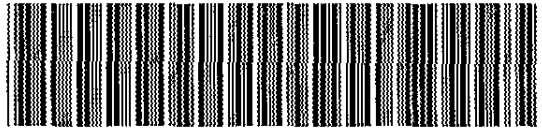

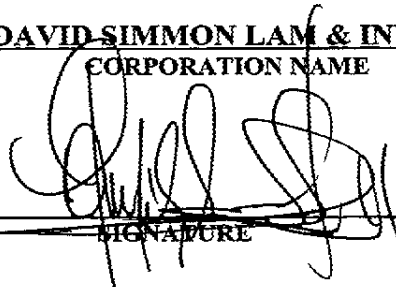
AMENDMENT ARTICLE I
