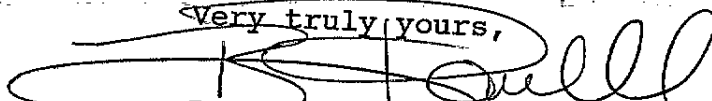

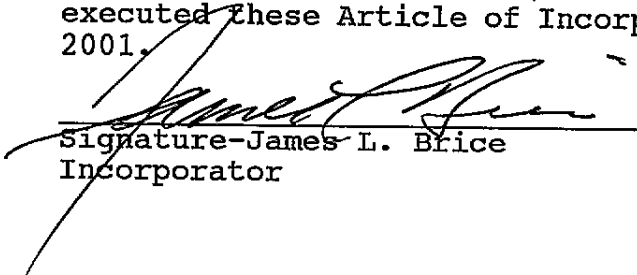
ARTICLES OF INCORPORATION

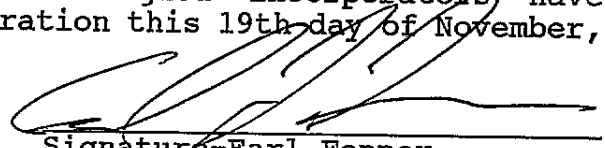

- ARTICLE I: The name of this corporation is **Sea-2-You, Inc.**
- ARTICLE II: The existence of the corporation shall begin on November 26, 2001.
- ARTICLE III: The principal place of business of the corporation shall be 2408 Zeder Ave., Delray Beach, Florida, 33444.
- ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.
- ARTICLE V: The initial street address of the corporation's **registered office** is 4600 W. Commercial Blvd., Suite 6, Fort Lauderdale, Florida 33319. the name of the initial registered agent is **Brandine E. Powell, Esquire.**

- ARTICLE VIII: The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permissible by law.
- ARTICLE IX: The purpose of the corporation shall be to operate a business in the perishable item seafood business.
