
ARTICLE VIII

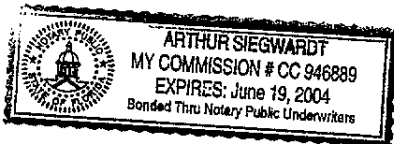


