**ARTICLES OF INCORPORATION**

**ARTICLE I = NAME**

The Name of this Corporation is Ornamental Designs Unlimited, Inc.

**ARTICLE II = DURATION**

This corporation shall have perpetual existence commencing the date of filing with the Secretary of State of Florida.

**ARTICLE III = PURPOSE**

The purpose for which the corporation is organized is the fabrication of metal, fences, gates and furniture for sale.

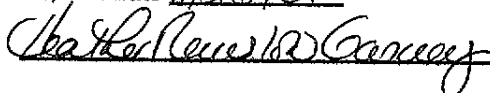

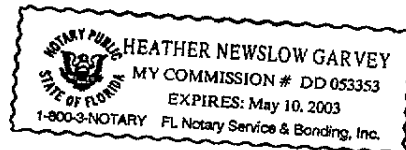
