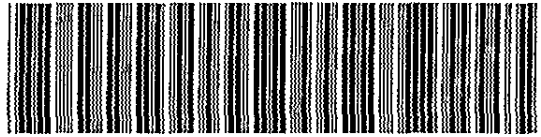

Pursuant to Section 607.1401, F.S.

Pursuant to section 607.1401, Florida Statutes, the undersigned corporation submits the following Articles of Dissolution:

FIRST: The name of the corporation is: ALL AROUND REPAIRS, INC.

SECOND: The corporation filed its Articles of Incorporation on December 3, 2001 under document number P01000113990; and the corporation authorized its dissolution on December 3, 2002, effective as of December 31, 2002.

THIRD: At the Annual Meeting of Shareholders, Directors and Officers of All Around Repairs, Inc., held on December 3, 2002 at 5:00 p.m., the company decided that since the corporation has not commenced business, all Shareholders, Officers and Directors approved Dissolution of the Corporation, effective as of December 31, 2002 at 10:00 p.m.; and, such unanimous vote was sufficient for Dissolution of the Corporation. Tony Delorenzo submitted his resignation, effective as of 10:00 p.m. this date, as sole Director and sole officer of All Around Repairs, Inc., leaving himself, Tony Delorenzo, as the sole Shareholder, of the Corporation authorized to do all acts needed to dissolve and wind-up the activities of the Corporation.


FOURTH: No debts exist for the corporation which remain unpaid.
