## ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

#### ARTICLE ONE: NAME

The name of the corporation is Amerifab International, Inc. and the address of its principal office is 4521 Chimney Creek Drive, Sarasota, Florida 34235, until and unless such address is subsequently changed by the corporation.

## ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence upon the filing of these Articles of Incorporation with the Florida Department of State and it shall exist perpetually thereafter until dissolved according to law.

#### ARTICLE THREE: PURPOSE

The corporation is organized for the purpose of transacting any and all business permitted corporations under Florida law.

### ARTICLE FOUR: CAPITALIZATION

The corporation shall have the authority to issue 1,000 shares of common stock with a par value of one dollar per share.

#### ARTICLE FIVE: REGISTERED OFFICE AND AGENT

### ARTICLE SIX: INCORPORATOR
