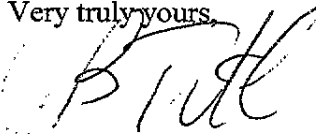

**ARTICLE I - Name**

The name of this incorporation is , WALLENQUEST LIMITED, INC.

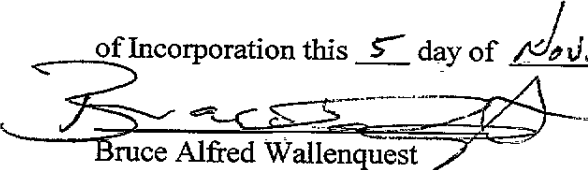
The offices of Secretary and Treasurer may be held by the same person at one and the same time.

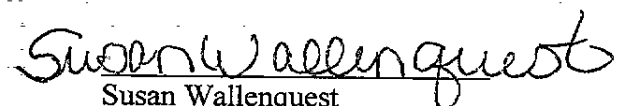

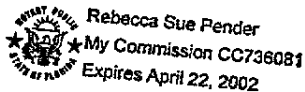
