AMENDMENT



PREEMPTIVE RIGHTS


The shareholder of the corporation shall have preemptive rights.

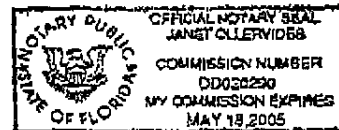
