ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be Wolfgang F. Mueller Dental Lab, Inc., and its principal office address is: 930 N. Krome Avenue, #2C, Homestead, FL 33030.

ARTICLE II. DURATION. This corporation is to exist perpetually.
