The undersigned being all of the shareholders, officers and directors of SUMMERSET LAWNS, INC., by unanimous vote, hereby state the articles of incorporation of SUMMERSET LAWNS, INC., pursuant to Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One-thousand shares of stock with a par value of One Dollar.

ARTICLE IV. ADDRESS

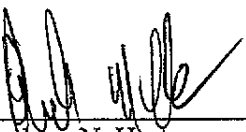

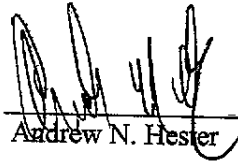
