ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of this Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I Name of Corporation

The name of this Corporation shall be "Dan's Workroom, Inc." The Corporation shall be referred to in this instrument as the "Corporation." These Articles of Incorporation shall be referred to as "Articles" and the Bylaws of the Corporation shall be referred to as "Bylaws."

ARTICLE II Term of Existence

The period of duration of the Corporation is perpetual.

ARTICLE III Purpose

The purpose or purposes for which the Corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State.
