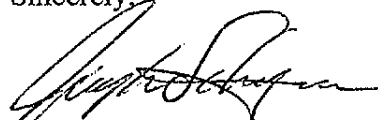

The undersigned Incorporator does hereby adopt the following Articles of Incorporation
under the Florida General Corporation Act:

COPY

ARTICLE I

The name of this corporation shall be **JERRY I. STONEKING, D.D.S., P.A.**

ARTICLE II

The Corporation's existence shall commence upon the date of the filing of these Articles of
Incorporation, and shall continue thereafter in perpetuity.

ARTICLE III

The general purpose, for which this corporation shall exist, shall be for the practice of
Dentistry as governed by Chapters 607 and 621 of the Florida Statutes.

ARTICLE IV

The corporation shall be authorized to issue an aggregate of Ten thousand (10,000) shares
of common voting stock, each such share to have a par value of One Dollar (\$1.00), and all such
shares being the same class.

ARTICLE V

All of the shareholders of this corporation shall be entitled to the benefits of preemptive rights with respect to any unissued or treasury shares of ownership of this corporation.

ARTICLE VI

COPY

The street address of the initial registered office of the corporation shall be 6600 Tenth Avenue North, St. Petersburg, FL 33710, and the initial registered agent for the Corporation shall be Jerry L. Stoneking, D.D.S., whose business address is identical to the address of the registered office of the corporation. The principal office of the Corporation shall be 6600 Tenth Avenue North, St. Petersburg, FL 33710.

ARTICLE VII

Initially, the corporation shall have a Board of Directors consisting of one (1) member whose name and address is as follows:

Jerry L. Stoneking, D.D.S. - 6600 Tenth Avenue N., St. Petersburg, FL 33710

The number of directors which shall constitute the Board, may from time to time hereafter, be increased or decreased pursuant to any By-Law which shall have been enacted or more specifically ratified by an affirmative vote of the shareholders at any annual meeting or at any special directors shall have the effect of shortening the term of any incumbent director.


ARTICLE VIII

The name and address of the Incorporator of this corporation is Jerry L. Stoneking, D.D.S., 6600 Tenth Avenue North, St. Petersburg, FL 33710.
